**NOTICE OF STANDARDS APPROVED**

After proceedings held in accordance with and pursuant to authority vested in Sections 142, 142.3 and 142.4 of the Labor Code to implement interpret, or make specific, the Occupational Safety and Health Standards Board, by a majority vote, adopted additions, revisions or deletions to the California Code of Regulations as follows:

1. Title 8, Division 1, Chapter 4, Subchapter 4, Construction Safety Orders, Article 2, Section 1504, Article 12, Section 1600, and Article 13, Sections 1602 through 1603.1, **Work Over or Near Water.**

Heard at the May 19, 2011, Public Hearing; adopted on June 16, 2011; filed with the Secretary of State on August 5, 2011; and will become effective on September 4, 2011.

2. Title 8, Division 1, Chapter 4, Subchapter 7, General Industry Safety Orders, Article 7, Sections 3302 and 3308, **Hazardous Liquids.**

Heard at the June 16, 2011, Public Hearing; adopted on July 21, 2011; filed with the Secretary of State on August 10, 2011; and will become effective on September 9, 2011.

3. Title 8, Division 1, Chapter 4, Subchapter 4, Construction Safety Orders, Article 2, Section 1504 and Subchapter 7, General Industry Safety Orders, Article 1, Section 3207, **Definition of Certified Safety Professional (CSP)**.

Heard at the May 19, 2011, Public Hearing; adopted on July 21, 2011; filed with the Secretary of State on August 29, 2011; and will become effective on September 28, 2011.
