NOTICE OF REGULATIONS APPROVED

After proceedings held in accordance with and pursuant to authority vested in Sections 142, 142.3 and 142.4 of the Labor Code to implement, interpret, or make specific, the Occupational Safety and Health Standards Board, by a majority vote, adopted additions, revisions or deletions to the California Code of Regulations, Title 8, Chapter 4, as follows:

1. Title 8; Chapter 4; Subchapter 18; Ship Building; Ship Repairing and Ship Breaking Safety Orders; Article 3; Section 8354 and Article 8; Section 8397.12 and New Sections 8397.14, 8397.15 and 8397.16; Fire Protection in Shipyard Employment II.

Heard at the October 20, 2005 Public Hearing; adopted on January 19, 2006; filed with the Secretary of State on February 22, 2006; and became effective on February 22, 2006.

2. Title 8; Chapter 4; Subchapter 7; General Industry Safety Orders; Article 24; Sections 3637, 3638, 3639, 3640, 3642 and 3646; Mast-Climbing Work Platforms.

Heard at the June 16, 2005, Public Hearing; adopted on January 19, 2006; filed with the Secretary of State on February 27, 2006; and will become effective on March 29, 2006.

3. Title 8, Chapter 4, Subchapter 4, Construction Safety Orders, Article 24, Section 1644, Metal Scaffolds.

Heard at the October 20, 2005, Public Hearing; adopted on January 19, 2006; filed with the Secretary of State on February 28, 2006; and will become effective on March 30, 2006.
