TO DEBARMENT

17 SHARON JIN YOO, an individual formerly doing
18 business as HY CARPENTRY
19 CONSTRUCTION and currently doing business
20 as DAUGHTER CONTSTRUCTION; and DAE
21 HYUN YOO, an individual and in his capacity as
22 manager and supervisor for SHARON JIN YOO
23 and in his capacity as General Partner for HY
24 CONSTRUCTION, a General Partnership.

25 Respondents.

26 Whereas, Respondents stipulated to debarment as follows:

27 1. Respondent SHARON JIN YOO is the holder of California Contractor's
28 license number 979297.

2. Respondent DAE HYUN YOO is a manager and supervisor for SHARON
JIN YOO as defined by Labor Code section 1777.1, subdivision (g).

1 3. Respondent DAE HYUN YOO was also the General Partner of the
2 partnership HY CONSTRUCTION, which was the holder of California Contractor's
3 license number 752894.

4 4. Respondents entered into the attached STIPULATION FOR
5 DEBARMENT.

6 5. Based on the STIPULATION FOR DEBARMENT, see Paragraph 6,
7 subsection B of the attached SETTLEMENT AGREEMENT AND RELEASE,
8 Respondent SHARON JIN YOO shall be ineligible for a period of one year, and
9 Respondent DAE HYUN YOO shall be ineligible for a period of three years, beginning
10 April 1, 2015, to do either of the following:


12 A) Bid on or be awarded a contract for a public works project; or

13 B) Perform work as a subcontractor on a public works project as defined
14 as Labor Code sections 1720, 1720.2, and 1720.3.
