**OPINION AND ORDER  
CORRECTING CLERICAL ERROR**

It has come to the Appeals Board's attention that its decision issued on July 18, 2022 contains a clerical error in the first and second sentences of page 10, where it lists the trial date of February 14, 2022 rather than the decision date of April 22, 2022. We will correct this clerical error by virtue of this order, without granting reconsideration as such errors may be corrected without further proceedings at any time. (*Toccalino v. Worker's Comp. Appeals Bd.* (1982) 128 Cal.App.3d 543, 558 [47 Cal.Comp.Cases 145]; see also 2 Cal. Workers' Comp. Practice (Cont. Ed. Bar, March 2018 Update) Supplemental Proceedings, § 23.74, p. 23-76.)

Accordingly, we now issue this Order correcting this clerical error and substituting the correct date of April 22, 2022 in the first and second sentences of page 10.

For the forgoing reasons,

**IT IS ORDERED** that the clerical error specifying the date of February 14, 2022 contained in Case No. ADJ7041227 in the first and second full sentences of page 10 of the Opinion and Order Granting Petition for Reconsideration and Decision After Reconsideration issued on July 18, 2022 is **CORRECTED** to reflect the decision date of April 22, 2022 in the first sentence of page 10, and again in the second sentence of page 10.
