Process was proposed to create a 3-person panel procedure to review comments for CAC consideration of appeals on non-traditional apprentice program applications. This was based off the model that is used for appeal panel decisions for apprentices.

Lots of discussion from the apprenticeship community.

A motion was made to recommend to the CAC. That the Chair of the CAC can create a 3-person panel to review comments on non-traditional apprentice program applications. That the members of these apprenticeship panels are commissioners and the commissioners can be from management, labor or the public sector representatives. Seconded and approved.

Approval of pre-apprenticeship program applications was discussed. No recommendations of procedure or processes moving forward.

#### IV. New Business

Under New Business, we reviewed Labor Code 1777.5(b)(2) language regarding apprentice pre-employment requirements. We suggested a presentation from DLSE regarding reporting any issues with employers requiring prerequisites that should not be there.

Resolution on the US DOL Proposed regulations on industry-recognized apprenticeship programs (IRAPs) was recommended for adoption was discussed. A motion and a second were made to bring before the CAC. All were in favor. The motion carried
