Updates:

As I reflect on our accomplishments in 2020, I want to remember all of those who have lost their lives to this awful virus. My wish is that we can get a handle on this pandemic and begin reopening an economy that is inclusive and will allow our fellow neighbors an opportunity to climb out of poverty. Thank you to our apprenticeship community for your perseverance, dedication and commitment to our apprentices. Your efforts have not gone unnoticed.

In looking at the year end numbers, there was a 3.1% increase of apprentices graduating in 2020 compared to 2019; however, there was a 2.1 % decrease in the number of apprentice registrations compared to the past two years. Apprenticeships are jobs and this pandemic has taken its toll on all industries.

During this quarter, I reached out to our registered pre-apprenticeship coordinators reminding them to register all pre-apprentices so that we can track and provide certificate of completions. This data will help us also analyze these programs as pre-apprentices become registered apprentices.

On January 8, 2021, Governor Newsom put out his proposed budget for the upcoming fiscal year. The Department of Better Jobs and Higher Wages is part of his budget. I will keep you all posted as we continue to go through the budget process.

DAS selected its vendors and purchased its software licenses that will allow us to have a cloud-based warehouse for our California Apprenticeship System and DAS purchased Tableau software, a business intelligence tool used to analyze our apprenticeship data.

I wish you all health, prosperity and blessing as we continue to train the next generation of skilled construction, firefighting, and emergency medical providers.

Field Office Activities

Our six field offices consultants continue to service our existing JACs, UACs and other program sponsors – attend your committee meetings, help on program revisions, annual self-assessments, audit/evaluation report compliance, apprentice disciplinary issues, public works compliance and any other advice and assistance you may need to continue the successful operation of your apprenticeship programs. Numerous committee reassignments have taken place and we expect more reassignments to equalize workload and services. We are continuing to draft new standards for the ‘California Apprenticeship Initiative’ grants.

Under direction of California Human Resources, we have updated our interview and selection procedures for hiring staff to fill the open positions throughout the state. We are experiencing retirements in most of our districts we are working to fill all our vacant positions as quickly as possible. Please note that the State has reintroduced our ‘Apprentice Consultant’ exam, so please share with anyone that is interested.

Apprenticeship Training Fund Check Processing

Federal Grants

Consolidated SAE Grants

The first round of SAE funding is coming to a close on March 31, 2021. The SAE consolidated grants were intended to build the Division of Apprenticeship Standards (DAS) capacity to expand

apprenticeship throughout California. The funding has benefited both traditional and non-traditional apprenticeships with the enhancement of the Division of Apprenticeship Standards (DAS) database system and the development of an internet-based registration system. The web-based on-line registration system has completely changed the work of DAS in that it has virtually eliminated all hard-copy paper work. DAS now keeps most all apprenticeship, OJT Trainee and pre-apprenticeship files electronically. The majority of transactions between DAS and the apprenticeship community are now electronic. The move to electronic filing has eliminated the need for staff to manually input apprenticeship agreements, cancellations and completions. The elimination of manual data input has allowed DAS to restructure its workforce and concentrate on hiring additional field personnel that can expand the apprenticeship training model to all California industries as well as State and local civil service agencies.

2020 SAE TIER I - \$450K IT Grant.

Department of Labor (DOL) recently awarded DAS with a \$450,000.00 grant to further enhance the DAS database. The funding will focus on developing support structures, resources, and activities that strengthen compliance such as building or renovating oversight systems that allow apprenticeship sponsors to register or update their standards quickly. The funding will improve system alignment for apprenticeship expansion, build state-wide capacity to increase the number and quality of Registered Apprenticeships through stronger alignment with the education and workforce systems. This base-line funding shall be used to improve data sharing and data integrity regarding statewide apprenticeship registration activities.

Statistics of December 31, 2020 this Council / California total

The active apprentices numbered **78,195 / 93,689**

New registrations and reinstatements numbered **3,197 / 3,586** for the quarter.

Minorities represented **68.1% / 69.1%** of all active apprentices.

Active women apprentices numbered **2,444 / 6,459**, which is **3.1% / 6.9%** of all active apprentices.

There are currently **7,072 / 8,003 veterans** active, **3,197 / 3,586** of which registered and **2,544 / 2,843** completed in 2020.

Program Evaluations January 1, 2020 through December 31, 2020

Since January 1, 2020, DAS opened seven (7) apprenticeship program evaluations. There were no program evaluations completed during December 2020. As of December 31, 2020, one (1) program evaluation is still in progress, and there are seventeen (17) programs with corrective action needed (thirteen (13) opened in 2019, four (4) opened in 2020). DAS field consultants are monitoring these programs to ensure their recommendations are completed.

DAS will continue to send new evaluation notification letters when programs reach their first year anniversary date or make substantial revisions, fall below the 50% industry graduation rate, and when programs have two or more meritorious complaints filed against them within a five (5) year period. To ensure high-quality apprenticeship administration, field consultants will assist programs with correcting the deficiencies found in order to close their evaluations/reviews.
