- Department of Better Jobs and Higher Wages. The Governor's budget for 2021-22 proposes to consolidate state workforce programs under a new Department of Better Jobs and Higher Wages. Specifically, the Governor proposes to consolidate employment, training, and data collection services currently conducted at various entities—workforce services at the Employment Development Department (EDD), workforce training at the California Workforce Development Board, apprenticeship programs at the Division of Apprenticeship Standards within the Department of Industrial Relations, and employer-sponsored training programs at the Employment Training Panel. Currently, these entities all reside within the state's Labor and Workforce Development Agency, which integrates policy to align the state's workforce programs.
- Discussed the Department of Better Jobs and Higher Wages as a possible topics for next quarter.
- Discussed a Forum on RSI and Distance Learning during this Covid-19 pandemic once mission critical documents are approved through the Chancellors office.
