represents a 40% rate increase in less than 2 decades. Suicide rates were significantly higher in five major industry groups with Construction being one of them. Also discussed him as a forum speaker at the California Conference of Apprenticeship in April.

- Suggested topic of Quality and Diversity in business, with active models that are working. Milwaukie Tool was suggested. A member of the apprenticeship stated that they had discussed recently a pilot program to get involved in apprenticeship, sponsoring graduations.
