
FROI/SROI Release 1 flat file layout and transaction record requirements

WCIS FROI/SROI Training Bulletin No.3

In an effort to reduce the percentage of transactions receiving TRs and TEs, DWC periodically issues training bulletins outlining some of the most common errors. An archive of the bulletins appears on the [WCIS website](#).

Files with invalid flat file layouts and transaction records will be rejected (TR) by WCIS.

Invalid flat file layouts and transaction record specifications result in preventable transaction rejections (TRs) and transactions accepted with error (TEs). In addition, they cause delays in transaction processing; a decrease in overall data quality; and, duplicative work for both the state and trading partners. Adherence to the flat file layout and transaction record specifications is mandatory.

Per section 4 of the IAIABC First and Subsequent Report of Injury © Release 1 implementation guide, there are several requirements for FROI and SROI flat file transaction record lengths:

- Header record length must be exactly 87 bytes.
- Trailer record length must be exactly 12 bytes.
- FROI (148) record length must be exactly 913 bytes.
- SROI (A49) record length must be a minimum of 208 bytes.

If a trading partner submits a file to WCIS that does not comply with these requirements, the entire file will be rejected and will not be processed. When a file is submitted incorrectly, a header level rejection acknowledgment (HD1TR) will be returned with the error 042 (Not statutorily valid) to inform trading partners of the file rejection. The FROI and SROI flat file record layout specifications can be found in the IAIABC implementation guide which is available through the IAIABC (<http://www.iaiaabc.org>).

Other causes for file rejections include the following:
