**ORDER OF SUSPENSION**

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about June 29, 2018, Respondent Celina Del Carmen Ayala, aka Celina Guevara, aka Ceelina Del Carmen Montoro, aka Celina Montero Ayala (Celina Del Carmen Ayala) pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the Superior Court of California, County of Los Angeles; and

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Celina Del Carmen Ayala was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

1           WHEREAS, on or about August 29, 2023, the Administrative Director mailed to  
2 Celina Del Carmen Ayala a written notice of the right to a hearing regarding the suspension  
3 and the procedure to follow to request a hearing, as provided in Labor Code section  
4 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

5           WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of  
6 Regulations, title 8, section 9788.1(d), the written notice advised Celina Del Carmen Ayala  
7 that the suspension would start thirty (30) calendar days after the date of mailing of written  
8 notice, unless Celina Del Carmen Ayala submitted a written request for a hearing within ten  
9 (10) calendar days of the date of mailing of the notice; and

10           WHEREAS, Celina Del Carmen Ayala did not submit a written request for hearing  
11 within ten (10) calendar days of the date of mailing of the notice; and

12           WHEREAS, the Administrative Director is required to suspend any physician,  
13 practitioner or provider pursuant to Labor Code section 139.21 and California Code of  
14 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was  
15 mailed, unless the physician, practitioner, or provider submits a written request for a  
16 hearing within ten (10) calendar days of the date of mail of the notice;

17           **IT IS HEREBY ORDERED** that Respondent Celina Del Carmen Ayala is hereby  
18 suspended from participating in the workers' compensation system as a physician,  
19 practitioner, or provider.
