WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Anthony Bell, Sr., that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Anthony Bell, Sr., submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and
