**ORDER OF SUSPENSION**

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about February 24, 2015, Sathish Narayanappa Babu pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the United States District Court, Northern District of Illinois, Eastern Division; and

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about May 28, 2015, Sathish Narayanappa Babu's license, certification or approval to provide health care services was surrendered or revoked by the Medical Board of California, Department of Consumer Affairs; and

WHEREAS, on or about October 13, 2017, the Administrative Director mailed to Sathish Narayanappa Babu a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,


1 title 8, section 9788.1(d), the written notice advised Sathish Narayanappa Babu that the suspension  
2 would start thirty (30) calendar days after the date of mailing of written notice, unless Sathish  
3 Narayanappa Babu submitted a written request for a hearing within ten (10) calendar days of the date of  
4 mailing of the notice; and

5 WHEREAS, Sathish Narayanappa Babu did not submit a written request for hearing within ten  
6 (10) calendar days of the date of mailing of the notice; and

7 WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or  
8 provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section  
9 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or  
10 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of  
11 the notice;

12 **IT IS HEREBY ORDERED** that Sathish Narayanappa Babu is hereby suspended from  
13 participating in the workers' compensation system as a physician, practitioner, or provider.
