	guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(I)(A)		
14	in United States District Court, Central District of California; and		
15	WHEREAS, on or about February 2, 2018, the Administrative Director mailed to Elizabeth		
16	Black a written notice of the right to a hearing regarding the suspension and the procedure to		
17	follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code		
18	of Regulations, title 8, section 9788.1; and		
19	WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of		
	Regulations, title 8, section 9788.1(d) the written notice advised Elizabeth Black that the		
20	suspension would start thirty (30) calendar days after the date of mailing of written notice, unless		
21	Elizabeth Black submitted a written request for a hearing within ten (10) calendar days of the		
22	date of mailing of the notice; and		
23	WHEREAS, Elizabeth Black did not submit a written request for hearing within ten (10)		
24	calendar days of the date of mailing of the notice; and		
25	WHEREAS, the Administrative Director is required to suspend any physician, practitioner,		
26	or provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations		
	section 9788.2, after thirty (30) days from the date of notice was mailed, unless the physician,		
27	practitioner, or provider submits a written request for a hearing within ten (10) calendar days of		
28	the date of mailing of the notice;
