ORDER OF SUSPENSION

JOSE VELASQUEZ DeJESUS,

Respondent.

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to
suspend any physician, practitioner, or provider from participating in the workers' compensation system
as a physician, practitioner, or provider whose license, certification or approval to provide health care
services has been surrendered or revoked; and

WHEREAS, on or about August 15, 2013, Jose Velasquez DeJesus license, certification or approval to provide health care services was surrendered or revoked by the Medical Board of California, Department of Consumer Affairs; and

WHEREAS, on or about September 7, 2018, the Administrative Director mailed to Jose Velasquez DeJesus a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Jose Velasquez DeJesus that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Jose Velasquez DeJesus submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, Jose Velasquez DeJesus did not submit a written request for hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or

1	provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of
2	the notice;
3	IT IS HEREBY ORDERED that Jose Velasquez DeJesus is hereby suspended from
4	participating in the workers' compensation system as a <u>physician</u> , practitioner, or provider.
