The Administrative Director of the Division of Workers' Compensation is required to suspend any physician, practitioner, or provider from participating in the California workers' compensation system as a physician, practitioner, or provider if the individual or entity meets any of the express criteria set forth in Labor Code section 139.21(a)(1).

Based upon a review of the record in this case, including the: (1) January 3, 2023 Party Stipulation re: Provider Suspension Hearing and Notice of Suspension; and (2) Order Referring Suspension to Administrative Director; Order Vacating Hearing, issued on January 3, 2023 by the Hon. Geoffrey H. Sims, the Administrative Director finds that Respondent Juan Gustavo Garza II, meets the criteria for suspension set forth in Labor Code section 139.21(a) and shall be suspended from participating in the California workers' compensation system as a physician, practitioner, or provider.

**IT IS HEREBY ORDERED** that Juan Gustavo Garza II, is hereby suspended from participating in the workers' compensation system as a physician, practitioner, or provider.
