WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating to the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about January 31, 2023, Respondent Gerald Patrick Gibson's license, certification, or approval to provide health care services was surrendered or revoked by the Medical Board of California, Department of Consumer Affairs; and

WHEREAS, on or about October 10, 2023, the Administrative Director mailed to Gerald Patrick Gibson a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Gerald Patrick Gibson that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Gerald Patrick Gibson submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, Gerald Patrick Gibson did not submit a written request for hearing within ten (10) calendar days of the date of mailing of the notice; and
