ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about August 13, 2014, Wilmer David Guzman pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the United States District Court, Central District of California; and

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Wilmer David Guzman was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, on or about August 10, 2018, the Administrative Director mailed to Wilmer David Guzman a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Wilmer David Guzman that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Wilmer David Guzman


1 submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the
2 notice; and

3 WHEREAS, Wilmer David Guzman did not submit a written request for hearing within ten (10)
4 calendar days of the date of mailing of the notice; and

5 WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or
6 provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section
7 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or
8 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of
9 the notice;

10 **IT IS HEREBY ORDERED** that Wilmer David Guzman is hereby suspended from
11 participating in the workers' compensation system as a physician, practitioner, or provider.
