WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about August 4, 2023, Respondent Darlena Dell Harper's, aka Darlene Dell Jones (Darlena Harper) license, certification, or approval to provide health care services was surrendered or revoked by the Board of Registered Nursing, Department of Consumer Affairs; and

WHEREAS, on or about June 4, 2024, the Administrative Director mailed to Darlena Harper a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Darlena Harper that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Darlena Harper submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and
