6	mailed, unless the physician, practitioner, or provider submits a written request for a
7	hearing within ten (10) calendar days of the date of mail of the notice;
8	IT IS HEREBY ORDERED that Respondent Brittany Irvin is hereby suspended from
9	participating in the workers' compensation system as a physician, practitioner, or provider.
