WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Dean Lewis that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Dean Lewis submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

8	IT IS HEREBY ORDERED that Respondent Dean Lewis is hereby suspended from
9	participating in the workers' compensation system as a physician, practitioner, or provider.
