5 ORDER OF SUSPENSION

6 In Re: PROVIDER SUSPENSION

7 STEPHEN R. LAUTERBACH,

8 Respondent.

9 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to  
10 suspend any physician, practitioner, or provider from participating in the worker's compensation  
11 system as a physician, practitioner, or provider whose license, certification or approval to  
12 provide health care services has been surrendered or revoked; and

13 WHEREAS, on or about August 25, 2017, Stephen Richard Lauterbach's license,  
14 certification or approval to provide health care services was surrendered or revoked by the  
15 Medical Board of California, Department of Consumer Affairs; and

16 WHEREAS, on or about February 16, 2018, the Administrative Director mailed to Stephen  
17 Richard Lauterbach a written notice of right to a hearing regarding the suspension and the  
18 procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and  
19 California Code of Regulations, title 8, section 9788.1; and


20 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of  
21 Regulations, title 8, section 9788.1(d) the written notice advised Stephen Richard Lauterbach that  
22 the suspension would start thirty (30) calendar days after the date of mailing of written notice,  
23 unless Stephen Richard Lauterbach submitted a written request for a hearing within ten (10)  
24 calendar days of the date of mailing of the notice; and

25 WHEREAS, Stephen Richard Lauterbach did not submit a written request for hearing  
26 within ten (10) calendar days of the date of mailing of the notice; and

27 WHEREAS, the Administrative Director is required to suspend any physician, practitioner,  
28 or provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations  
section 9788.2, after thirty (30) days from the date of notice was mailed, unless the physician,  
practitioner, or provider submits a written request for a hearing within ten (10) calendar days of  
the date of mailing of the notice;

1           **IT IS HEREBY ORDERED** Stephen Richard Lauterbach is hereby suspended from  
2 participating in the workers' compensation system as a physician, practitioner, or provider.
