**ORDER OF SUSPENSION**

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about June 13, 2017, Irineo Mallari's license, certification or approval to provide health care services was surrendered or revoked by the California Board of Registered Nursing, Department of Consumer Affairs; and

WHEREAS, on or about May 18, 2018, the Administrative Director mailed to Irineo Mallari a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Irineo Mallari that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Irineo Mallari submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, Irineo Mallari did not submit a written request for hearing within ten (10) calendar days of the date of mailing of the notice; and



WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or

1 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of  
2 the notice;

3 **IT IS HEREBY ORDERED** that Irineo Mallari is hereby suspended from participating in the  
4 workers' compensation system as a physician, practitioner, or provider.
