Labor Code section 139.21(a)(1)(D) requires the Administrative Director of the Division of Workers' Compensation (Administrative Director) to suspend any entity from participating in the California workers' compensation system as a physician, practitioner, or provider if the entity controlled by an individual who has been convicted of a felony or misdemeanor described in Labor Code section 139.21(a)(1)(A).

Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the California workers' compensation system as a physician, practitioner, or provider if the individual or entity has been convicted of any felony or misdemeanor and that crime either: (1) involves fraud or abuse of the federal Medicare or Medicaid programs, the Medi-Cal program, or the workers' compensation system, or fraud or abuse of any patient; (2) relates to the conduct of the individual's medical practice as it pertains to patient care; or (3) is a financial crime that relates to the federal Medicare or Medicaid programs, the Medi-Cal program, or the workers' compensation system.

Labor Code section 139.21(a)(3) provides that an entity is controlled by an individual if the individual: (1) is or was an officer or director of the entity; (2) is or was a shareholder with a 10 percent or greater interest in the entity; or (3) held de facto ownership of the entity or de facto control consistent with the rights and duties of an officer or director of the entity. (See Villanueva v. Teva Foods (2019) WCAB Case No. ADJ9332041, 84 Cal. Comp. Cases 198 [significant panel decision].)

1 On or about November 15, 2021, Shilpa Kapadia, an individual, was convicted in  
2 the Superior Court of the State of California, County of Riverside, of a crime described  
3 in Labor Code section 139.21(a)(1)(A). (People v. Kapadia et al., Case No.  
4 RIF2104842.)

5 On or about November 15, 2021, Alpa Craig Brown, an individual, was convicted  
6 in the Superior Court of the State of California, County of Riverside, of a crime  
7 described in Labor Code section 139.21(a)(1)(A). (People v. Brown et al., Case No.  
8 RIF2104842.)

9 Respondent One World Translation Services is controlled by Shilpa Kapadia and  
10 Alpa Craig Brown pursuant to Labor Code section 139.21(a)(3).

11 On or about November 10, 2022, the Administrative Director mailed to  
12 Respondent One World Translation Services a written notice of the right to a hearing  
13 regarding the suspension and the procedure to follow to request a hearing, as provided  
14 in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section  
15 9788.1.

16 Pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,  
17 title 8, section 9788.1(d), the written notice advised Respondent One World Translation  
18 Services that the suspension would start thirty (30) calendar days after the date of  
19 mailing of written notice, unless Respondent One World Translation Services submitted  
20 a written request for a hearing within ten (10) calendar days of the date of mailing of the  
21 notice.

22 Respondent One World Translation Services did not submit a written request for  
23 hearing within ten (10) calendar days of the date of mailing of the notice.

24 The Administrative Director is required to suspend any physician, practitioner, or  
25 provider pursuant to Labor Code section 139.21 and California Code of Regulations,  
26 title 8, section 9788.2, after thirty (30) days from the date the notice was mailed, unless  
27 the physician, practitioner, or provider submits a written request for a hearing within ten  
28 (10) calendar days of the date of mailing of the notice.

1           **IT IS HEREBY ORDERED** that Respondent One World Translation Services is  
2 hereby suspended from participating in the California workers' compensation system as  
3 a physician, practitioner, or provider.
