ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Respondent Bruce Eugene Osborn (Bruce Osborn) was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about May 18, 2023, Bruce Osborn's license, certification, or approval to provide health care services was surrendered or revoked by the California Board of Behavioral Sciences, Department of Consumer Affairs; and

WHEREAS, on or about April 7, 2025, the Administrative Director mailed to Bruce Osborn a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

1 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
2 Regulations, title 8, section 9788.1(d), the written notice advised Bruce Osborn that the
3 suspension would start thirty (30) calendar days after the date of mailing of written notice,
4 unless Bruce Osborn submitted a written request for a hearing within ten (10) calendar
5 days of the date of mailing of the notice; and

6 WHEREAS, Bruce Osborn did not submit a written request for hearing within ten
7 (10) calendar days of the date of mailing of the notice; and

8 WHEREAS, the Administrative Director is required to suspend any physician,
9 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
10 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
11 mailed, unless the physician, practitioner, or provider submits a written request for a
12 hearing within ten (10) calendar days of the date of mail of the notice;

13 **IT IS HEREBY ORDERED** that Respondent Bruce Osborn is hereby suspended
14 from participating in the workers' compensation system as a physician, practitioner, or
15 provider.
