Your February 16, 2018 Notice of Provider Suspension--Workers' Compensation

Dear Mr. Parisotto and DWC Legal Unit:

We represent John F. Petraglia, whose mailing address is 2528 Cliff Drive, Newport Beach, California 92663. We are in receipt of your February 16, 2018 Notice of Provider Suspension—Workers' Compensation setting forth the Division of Workers' Compensation intent to suspend Mr. Petraglia's participation in the California Workers' Compensation system pursuant to section 139.21(a)(1)(C). A copy of your letter is enclosed. The given reason is that Mr. Petraglia's license to provide health care services has been surrendered or revoked.

It is correct that his medical license has been revoked by decision of the Medical Board of California effective September 20, 2017. But that revocation order, though now in effect, is not

a final decision. A petition for administrative writ of mandate has been filed with the Los Angeles Superior Court, Case No. BS170880, requesting that the decision be set aside. Enclosed is a copy of the writ petition.

At this point, a suspension from participation in the Workers' Compensation system is not necessary, because he cannot practice medicine, much less provide care in the Workers' Compensation system. Secondly, it is premature because the basis upon which you would rely is not yet a final decision . . . and it may well be overturned.

It requested that you hold off on your proposed action until after the hearing and determination of the writ petition challenging the Medical Board revocation order. Again, he cannot now practice, so there is no need for the proposed action. If the license revocation is upheld by the Court, you can proceed if you wish. If it is overturned by the Court, then there would be no reason for your proposed action.

A decision by the Superior Court will not take place anytime soon. No hearing date on the writ petition has yet been set.

If for any reason you are unwilling to hold off on your proposed action, then Mr. Petraglia hereby requests a hearing.

As requested, accompanying this original letter/ request for hearing is a copy, along with a copy served on the DWC Legal Unit.
