ORDER OF SUSPENSION

11 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director
12 to suspend any physician, practitioner, or provider from participating to the workers'
13 compensation system as a physician, practitioner, or provider whose license, certification,
14 or approval to provide health care services has been surrendered or revoked; and

15 WHEREAS, on or about November 3, 2016, Ulana C. Rey's license, certification, or
16 approval to provide health care services was surrendered or revoked by the California
17 Board of Pharmacy, Department of Consumer Affairs; and

18 WHEREAS, on or about August 21, 2023, the Administrative Director mailed to
19 Ulana C. Rey a written notice of the right to a hearing regarding the suspension and the
20 procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2)
21 and California Code of Regulations, title 8, section 9788.1; and

22 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
23 Regulations, title 8, section 9788.1(d), the written notice advised Ulana C. Rey that the
24 suspension would start thirty (30) calendar days after the date of mailing of written notice,
25 unless Ulana C. Rey submitted a written request for a hearing within ten (10) calendar days
26 of the date of mailing of the notice; and

27 WHEREAS, Ulana C. Rey did not submit a written request for hearing within ten (10)
28 calendar days of the date of mailing of the notice; and

WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or provider pursuant to Labor Code section 139.21 and California Code of Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of the notice;

IT IS HEREBY ORDERED that Respondent Ulana C. Rey is hereby suspended from participating in the workers' compensation system as a physician, practitioner, or provider.
