WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Greg Rodgers that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Greg Rodgers submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

8	IT IS HEREBY ORDERED that Respondent Greg Rodgers is hereby suspended
9	from participating in the workers' compensation system as a physician, practitioner, or
