**ORDER OF SUSPENSION**

FARHAD N. DANY SHARIM,  
Respondent.

10 WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to  
11 suspend any physician, practitioner, or provider from participating in the workers' compensation system  
12 as a physician, practitioner, or provider if the individual has been convicted of any felony or  
13 misdemeanor described in Labor Code section 139.21(a)(1)(A); and

14 WHEREAS, on or about November 18, 2013, Farhad Sharim pled guilty to or was found guilty  
15 of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the United  
16 States District Court, Central District California; and

17 WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to  
18 suspend any physician, practitioner, or provider from participating in the workers' compensation system  
19 as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal  
20 Medicare or Medicaid programs; and

21 WHEREAS, Farhad Sharim was suspended, due to fraud or abuse, from the federal Medicare or  
22 Medicaid programs; and

23 WHEREAS, on or about July 27, 2018, the Administrative Director mailed to Farhad Sharim a  
24 written notice of the right to a hearing regarding the suspension and the procedure to follow to request a  
25 hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8,  
26 section 9788.1; and

27 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,  
28 title 8, section 9788.1(d), the written notice advised Farhad Sharim that the suspension would start thirty  
(30) calendar days after the date of mailing of written notice, unless Farhad Sharim submitted a written

1 request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

2 WHEREAS, Farhad Sharim did not submit a written request for hearing within ten (10) calendar  
3 days of the date of mailing of the notice; and

4 WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or  
5 provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section  
6 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or  
7 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of  
8 the notice;

9 **IT IS HEREBY ORDERED** that Farhad Sharim is hereby suspended from participating in the  
10 workers' compensation system as a physician, practitioner, or provider.
