ORDER OF SUSPENSION

10 WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to
11 suspend any physician, practitioner, or provider from participating in the workers' compensation system
12 as a physician, practitioner, or provider if the individual has been convicted of any felony or
13 misdemeanor described in Labor Code section 139.21(a)(1)(A); and

14 WHEREAS, on or about February 1, 2018, Paul Andrew Stanton pled guilty to or was found
15 guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the
16 Superior Court of California, County of Orange; and

17 WHEREAS, on or about February 15, 2019, the Administrative Director mailed to Paul Andrew
18 Stanton a written notice of the right to a hearing regarding the suspension and the procedure to follow to
19 request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations,
20 title 8, section 9788.1; and

21 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,
22 title 8, section 9788.1(d), the written notice advised Paul Andrew Stanton that the suspension would start
23 thirty (30) calendar days after the date of mailing of written notice, unless Paul Andrew Stanton
24 submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the
25 notice; and


26 WHEREAS, Paul Andrew Stanton did not submit a written request for hearing within ten (10)
27 calendar days of the date of mailing of the notice; and

28 WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or
provider pursuant to Labor Code section 139.21 and title 8, California Code of Regulations section

1 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or
2 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of
3 the notice;

4 **IT IS HEREBY ORDERED** that Paul Andrew Stanton is hereby suspended from participating
5 in the workers' compensation system as a physician, practitioner, or provider.
