**ORDER OF SUSPENSION**

10 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to  
11 suspend any physician, practitioner, or provider from participating in the workers' compensation system  
12 as a physician, practitioner, or provider whose license, certification or approval to provide health care  
13 services has been surrendered or revoked; and

14 WHEREAS, on or about April 17, 2017, Manuel Tanguma III's license, certification or approval  
15 to provide health care services was surrendered or revoked by the Medical Board of California,  
16 Department of Consumer Affairs; and

17 WHEREAS, on or about December 15, 2017, the Administrative Director mailed to Manuel  
18 Tanguma III a written notice of the right to a hearing regarding the suspension and the procedure to  
19 follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of  
20 Regulations, title 8, section 9788.1; and

21 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,  
22 title 8, section 9788.1(d), the written notice advised Manuel Tanguma III that the suspension would start  
23 thirty (30) calendar days after the date of mailing of written notice, unless Manuel Tanguma III  
24 submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the  
25 notice; and


26 WHEREAS, Manuel Tanguma III did not submit a written request for hearing within ten (10)  
27 calendar days of the date of mailing of the notice; and

28 WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or  
provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section

1 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or  
2 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of  
3 the notice;

4 **IT IS HEREBY ORDERED** that Manuel Tanguma III is hereby suspended from participating  
5 in the workers' compensation system as a physician, practitioner, or provider.
