8 ORDER OF SUSPENSION

9 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to  
10 suspend any physician, practitioner, or provider from participating in the workers'  
11 compensation system as a physician, practitioner, or provider whose license, certification, or  
12 approval to provide health care services has been surrendered or revoked; and

13 WHEREAS, on or about March 30, 2017, Respondent Jaime A. Villatoro's license,  
14 certification, or approval to provide health care services was surrendered or revoked by the  
15 California Respiratory Care Board, Department of Consumer Affairs; and

16 WHEREAS, on or about April 26, 2023, the Administrative Director mailed to Jaime  
17 Villatoro a written notice of the right to a hearing regarding the suspension and the procedure  
18 to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California  
19 Code of Regulations, title 8, section 9788.1; and

20 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of  
21 Regulations, title 8, section 9788.1(d), the written notice advised Jaime Villatoro that the  
22 suspension would start thirty (30) calendar days after the date of mailing of written notice,  
23 unless Jaime Villatoro submitted a written request for a hearing within ten (10) calendar days  
24 of the date of mailing of the notice; and

25 WHEREAS, Jaime Villatoro did not submit a written request for hearing within ten (10)  
26 calendar days of the date of mailing of the notice; and

1           WHEREAS, the Administrative Director is required to suspend any physician,  
2 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of  
3 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was mailed,  
4 unless the physician, practitioner, or provider submits a written request for a hearing within ten  
5 (10) calendar days of the date of mailing of the notice;

6           **IT IS HEREBY ORDERED** that Jaime A. Villatoro is hereby suspended from  
7 participating in the workers' compensation system as a physician, practitioner, or provider.
