ORDER OF SUSPENSION

RUDOLPH SALVADOR YBARRA, JR.,
Respondent.

10 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to
11 suspend any physician, practitioner, or provider from participating in the workers' compensation system
12 as a physician, practitioner, or provider whose license, certification or approval to provide health care
13 services has been surrendered or revoked; and

14 WHEREAS, on or about March 16, 2017, Rudolph Salvador Ybarra, Jr.'s license, certification or
15 approval to provide health care services was surrendered or revoked by the California Board of
16 Registered Nursing, Department of Consumer Affairs; and

17 WHEREAS, on or about September 7, 2018, the Administrative Director mailed to Rudolph
18 Salvador Ybarra, Jr. a written notice of the right to a hearing regarding the suspension and the procedure
19 to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of
20 Regulations, title 8, section 9788.1; and

21 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,
22 title 8, section 9788.1(d), the written notice advised Rudolph Salvador Ybarra, Jr. that the suspension
23 would start thirty (30) calendar days after the date of mailing of written notice, unless Rudolph Salvador
24 Ybarra, Jr. submitted a written request for a hearing within ten (10) calendar days of the date of mailing
25 of the notice; and


26 WHEREAS, Rudolph Salvador Ybarra, Jr. did not submit a written request for hearing within ten
27 (10) calendar days of the date of mailing of the notice; and

28 WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or
provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section

1 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or
2 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of
3 the notice;

4 **IT IS HEREBY ORDERED** that Rudolph Salvador Ybarra, Jr. is hereby suspended from
5 participating in the workers' compensation system as a physician, practitioner, or provider.
