

PREDETERMINED INCREASE

LOCALITIES:

All localities within Alpine, Amador, Calaveras, Del Norte, Fresno, Humboldt, Kern, Kings, Lake, Madera, Mariposa, Mendocino, Merced, Sacramento, San Joaquin, Sonoma, Stanislaus, Tulare, and Tuolumne Counties (REF: 61-1245-12)

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after September 1, 2016, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project, has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

Determination C-TT-2016-1 is currently in effect and expires on July 29, 2017**.

Effective July 30, 2017, there will be an increase of \$0.23 to the Basic Hourly Rate, \$0.01 to Vacation and \$0.01 to Holiday.

Climber after 3 years of service: Effective July 30, 2017, there will be an increase of \$0.23 to the Basic Hourly Rate, \$0.01 to Pension, \$0.01 to Vacation and \$0.01 to Holiday.

Climber after 10 years of service: Effective July 30, 2017, there will be an increase of \$0.23 to the Basic Hourly Rate, \$0.01 to Pension, \$0.01 to Vacation and \$0.01 to Holiday.

GROUNDPERSON: First 6 months

Effective July 30, 2017, there will be an increase of \$0.15 to the Basic Hourly Rate and \$0.01 to Pension.

GROUNDPERSON: After 6 months

Effective July 30, 2017, there will be an increase of \$0.16 to the Basic Hourly Rate \$0.01 to Pension and \$0.01 to Holiday.

Climber after 3 years of service: Effective July 30, 2017, there will be an increase of \$0.16 to the Basic Hourly Rate, \$0.01 to Pension, \$0.01 to Vacation and \$0.01 to Holiday.

Climber after 10 years of service: Effective July 30, 2017, there will be an increase of \$0.16 to the Basic Hourly Rate, \$0.01 to Pension, \$0.01 to Vacation and \$0.01 to Holiday

There will be no further increases applicable to this determination.
