

PREDETERMINED INCREASE

CRAFT/CLASSIFICATIONS:

Electrical Utility Lineman (Lineman, Cable Splicer, Powderman, Groundman)

DETERMINATION:

C-61-X-3-2017-2

LOCALITIES:

All localities within the State of California except Del Norte, Modoc, and Siskiyou Counties

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after September 1, 2017, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project, has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

Determination C-61-X-3-2017-2 is currently in effect and expires on December 31, 2017**

Effective January 1, 2018, there will be an increase of \$0.25 to Health and Welfare.

Effective June 1, 2018, there will be an increase of \$2.30 allocated as follows: \$1.30 to BHR, \$0.25 to H&W, and \$0.75 to Pension.

Effective January 1, 2019, there will be an increase of \$0.25 to Health and Welfare.

Effective June 1, 2019, there will be an increase of \$2.45 to be allocated as follows: \$1.30 to the Basic Hourly Rate, \$0.25 to Health and Welfare and \$0.90 to Pension.

Effective January 1, 2020, there will be an increase of \$0.25 to wages and/or fringes.

Effective June 1, 2020, there will be an increase of \$2.05 to be allocated as follows: \$1.05 to the Basic Hourly Rate and \$1.00 to Pension.

Effective June 1, 2021, there will be an increase of \$2.05 to be allocated as follows: \$1.05 to the Basic Hourly Rate and \$1.00 to wages and/or fringes.

ELECTRICAL UTILITY LINEMAN: POWDERMAN

Determination C-61-X-3-2017-2 is currently in effect and expires on December 31, 2017**

Effective January 1, 2018, there will be an increase of \$0.25 to Health and Welfare.

Effective June 1, 2018, there will be an increase of \$2.16 allocated as follows: \$1.16 to BHR, \$ 0.25 to H&W and \$0.75 to Pension.

Effective January 1, 2019, there will be an increase of \$0.25 to Health and Welfare.

Effective June 1, 2019, there will be an increase of \$2.31 to be allocated as follows: \$1.16 to the Basic Hourly Rate, \$0.25 to Health and Welfare and \$0.90 to Pension.

Effective January 1, 2020, there will be an increase of \$0.25 to wages and/or fringes.

Effective June 1, 2020, there will be an increase of \$1.94 to be allocated as follows: \$0.94 to the Basic Hourly Rate and \$1.00 to Pension.

Effective June 1, 2021, there will be an increase of \$1.94 to be allocated as follows: \$0.94 to the Basic Hourly Rate, \$0.01 to Training, and \$0.99 to wages and/or fringes.

There are no further increases applicable to this determination.

ELECTRICAL UTILITY LINEMAN: GROUNDMAN

Determination C-61-X-3-2017-2 is currently in effect and expires on December 31, 2017**

Effective January 1, 2018, there will be an increase of \$0.25 to Health and Welfare.

Effective June 1, 2018, there will be an increase of \$1.79 allocated as follows: \$0.79 to BHR, \$0.25 to H&W and \$0.75 to Pension. (See Important Notice dated January 18, 2018).

Effective January 1, 2019, there will be an increase of \$0.25 to Health and Welfare.

Effective June 1, 2019, there will be an increase of \$1.94 to be allocated as follows: \$0.79 to the Basic Hourly Rate, \$0.25 to Health and Welfare and \$0.90 to Pension.

Effective January 1, 2020, there will be an increase of \$0.25 to wages and/or fringes.

Effective June 1, 2020, there will be an increase of \$1.65 to be allocated as follows: \$0.65 to the Basic Hourly Rate and \$1.00 to Pension.

Effective June 1, 2021, there will be an increase of \$1.64 to be allocated as follows: \$0.64 to the Basic Hourly Rate and \$1.00 to wages and/or fringes.

There are no further increases applicable to this determination.
