

## PREDETERMINED INCREASE

### **CRAFT/CLASSIFICATION:**

Tree Trimmer (Line Clearance)

### **DETERMINATION:**

C-TT-61-47-3-2017-1

### **LOCALITIES:**

All localities within Inyo, Los Angeles, Mono, Orange, Riverside, San Bernardino, Santa Barbara, and Ventura Counties

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after March 4, 2017, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project, has a single asterisk (\*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (\*\*) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

### **TREE TRIMMER: Steps 1 through 4**

Determination C-TT-61-47-3-2017-1 is currently in effect and expires on December 30, 2017\*\*.

Effective December 31, 2017, there will be the following increases for each of the steps:

Step 1: \$0.30 to the Basic Hourly Rate and \$0.01 to Vacation/Holiday

Step 2: \$0.31 to the Basic Hourly Rate and \$0.02 to Vacation/Holiday

Step 3: \$0.33 to the Basic Hourly Rate and \$0.02 to Vacation/Holiday

Step 3 after 2 years of service: \$0.33 to the Basic Hourly Rate and \$0.02 to Vacation/Holiday

Step 3 after 10 years of service: \$0.33 to the Basic Hourly Rate and \$0.03 to Vacation/Holiday

Step 4: \$0.34 to the Basic Hourly Rate and \$0.01 to Vacation/Holiday

Step 4 after 2 years of service: \$0.34 to the Basic Hourly Rate and \$0.02 to Vacation/Holiday

Step 4 after 10 years of service: \$0.34 to the Basic Hourly Rate and \$0.03 to Vacation/Holiday

Effective December 30, 2018, there will be the following increases for each of the steps:

Step 1: \$0.34 to the Basic Hourly Rate and \$0.02 to Vacation/Holiday

Step 2: \$0.36 to the Basic Hourly Rate and \$0.02 to Vacation/Holiday

Step 3: \$0.37 to the Basic Hourly Rate and \$0.02 to Vacation/Holiday

Step 3 after 2 years of service: \$0.37 to the Basic Hourly Rate and \$0.02 to Vacation/Holiday

Step 3 after 10 years of service: \$0.37 to the Basic Hourly Rate and \$0.03 to Vacation/Holiday

Step 4: \$0.39 to the Basic Hourly Rate and \$0.02 to Vacation/Holiday

Step 4 after 2 years of service: \$0.39 to the Basic Hourly Rate and \$0.02 to Vacation/Holiday

Step 4 after 10 years of service: \$0.39 to the Basic Hourly Rate and \$0.04 to Vacation/Holiday

There will be no further increases applicable to this determination.

### **TREE TRIMMER TRAINEE:**

Determination C-TT-61-47-3-2017-1 is currently in effect and expires on December 30, 2017\*\*.

Effective December 31, 2017, there will be the following increases:

\$0.28 to the Basic Hourly Rate and \$0.01 to Vacation/Holiday

Effective December 30, 2018, there will be the following increases:

\$0.32 to the Basic Hourly Rate and \$0.01 to Vacation/Holiday

There will be no further increases applicable to this determination.
