

IMPORTANT NOTICE TO AWARDING BODIES AND ALL INTERESTED PARTIES REGARDING CORRECTIONS TO THE DIRECTOR'S GENERAL PREVAILING WAGE DETERMINATIONS

The employer payments were misaligned resulting in an improper straight time total hourly rate and overtime rates. The straight time total hourly rate should be \$69.61 not \$63.24. The daily and Saturday overtime hourly rates should be \$88.90 not \$82.53. The Sunday and Holiday overtime hourly rate should be \$108.19 not 101.82.

With the exception of the above correction, all of the wage rates and other conditions found in the above referenced prevailing wage determinations remain unchanged.

The daily and Saturday overtime hourly rates should be \$85.50 not \$79.28. The Sunday and Holiday overtime hourly rate should be \$103.74 not \$97.52.

With the exception of the above correction, all of the wage rates and other conditions found in the above referenced prevailing wage determinations remain unchanged.
