

PREDETERMINED INCREASE

LOCALITIES:

All localities within Imperial, Inyo, Kern, Los Angeles, Mono, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara, and Ventura Counties

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after September 1, 2018, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project, has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

Plumber (All Shifts):

Determination SC-204-X-18-2018-1 is currently in effect and expires on August 31, 2019**.

Effective September 1, 2019, there will be the following increases:

Class I: \$0.89 to be allocated as follows: \$0.64 to Basic Hourly Rate and \$0.25 to Health and Welfare.

Class II: \$1.06 to be allocated as follows: \$0.81 to Basic Hourly Rate and \$0.25 to Health and Welfare.

Class III: \$1.36 to be allocated as follows: \$0.61 to Basic Hourly Rate, \$0.25 to Health and Welfare and \$0.50 to Pension

Class IV: \$1.49 to be allocated as follows: \$0.74 to Basic Hourly Rate, \$0.25 to Health and Welfare and \$0.50 to Pension.

Effective September 1, 2020, there will be the following increases:

Class I: \$0.92 to be allocated as follows: \$0.37 to Basic Hourly Rate, \$0.25 to Health and Welfare and \$0.30 to Other.

Class II: \$1.09 to be allocated as follows: \$0.54 to Basic Hourly Rate, \$0.25 to Health and Welfare and \$0.30 to Other.

Class III: \$1.40 to be allocated as follows: \$0.35 to Basic Hourly Rate, \$0.25 to Health and Welfare, \$0.50 to Pension and \$0.30 to Other.

Class IV: \$1.54 to be allocated as follows: \$0.49 to Basic Hourly Rate, \$0.25 to Health and Welfare, \$0.50 to Pension and \$0.30 to Other.

There will be no further increases applicable to this determination.
