REGARDING A MODIFICATION TO
THE DIRECTOR'S GENERAL PREVAILING WAGE APPRENTICE RATES**

CRAFT: Apprentice Plumber

CLASSIFICATION: Apprentice Plumber, Pipefitter, Steamfitter (All Shifts)

LOCALITIES: All localities within Imperial, Los Angeles, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara, and Ventura Counties

DETERMINATION: 2018-1, 2018-2, 2019-1, 2019-2, 2020-1, 2020-2, 2021-1, 2021-2, 2022-1

The predetermined increase of \$2.26 scheduled to take effect on September 1, 2022 has been reduced. The correct predetermined increase is as follows:

Shift 1:

Effective September 1, 2022, there is an increase as follows:

Period 1: \$0.80 allocated to wages and/or fringes.

Period 2: \$1.06 allocated to wages and/or fringes.

Period 3: \$1.74 allocated to wages and/or fringes.

Period 4: \$1.87 allocated to wages and/or fringes.

Period 5: \$2.00 allocated to wages and/or fringes.

Shift 2:

Effective September 1, 2022, there is an increase as follows:

Period 1: \$0.89 to be allocated to wages and/or fringes.

Period 2: \$1.16 to be allocated to wages and/or fringes.

Period 3: \$1.86 to be allocated to wages and/or fringes.

Period 4: \$2.01 to be allocated to wages and/or fringes.

Period 5: \$2.16 to be allocated to wages and/or fringes.

The predetermined increase of \$2.39 scheduled to take effect on September 1, 2022 has been reduced. The correct predetermined increase is as follows:

Shift 1:

Effective September 1, 2022, there is an increase as follows:

- Period 1: \$0.86 to be allocated to wages and/or fringes.
- Period 2: \$1.12 to be allocated to wages and/or fringes.
- Period 3: \$1.82 to be allocated to wages and/or fringes.
- Period 4: \$1.96 to be allocated to wages and/or fringes.
- Period 5: \$2.10 to be allocated to wages and/or fringes.

Shift 2:

Effective September 1, 2022, there is an increase as follows:

- Period 1: \$0.95 to be allocated to wages and/or fringes.
- Period 2: \$1.23 to be allocated to wages and/or fringes.
- Period 3: \$1.95 to be allocated to wages and/or fringes.
- Period 4: \$2.11 to be allocated to wages and/or fringes.
- Period 5: \$2.28 to be allocated to wages and/or fringes.

The predetermined increase of \$2.39 scheduled to take effect on September 1, 2022 has been reduced. The correct predetermined increase is as follows:

Shift 1:

Effective September 1, 2022, there is an increase as follows:

- Period 1: \$0.86 allocated to wages and/or fringes.
- Period 2: \$1.12 allocated to wages and/or fringes.
- Period 3: \$1.82 allocated to wages and/or fringes.
- Period 4: \$1.96 allocated to wages and/or fringes.
- Period 5: \$2.10 allocated to wages and/or fringes.

Shift 2:

Effective September 1, 2022, there is an increase as follows:

- Period 1: \$0.95 allocated to wages and/or fringes.
- Period 2: \$1.23 allocated to wages and/or fringes.
- Period 3: \$1.95 allocated to wages and/or fringes.
- Period 4: \$2.11 allocated to wages and/or fringes.
- Period 5: \$2.28 allocated to wages and/or fringes.

DETERMINATION: 2018-1, 2018-2, 2019-1, 2019-2, 2020-1, 2020-2, 2021-1, 2021-2, 2022-1

The predetermined increase of \$2.26 scheduled to take effect on September 1, 2022 has been reduced. The correct predetermined increase is as follows:

Shift 1:

Effective September 1, 2022, there is an increase as follows:

Period 1: \$1.06 allocated to wages and/or fringes.

Period 2: \$1.19 allocated to wages and/or fringes.

Period 3: \$1.87 allocated to wages and/or fringes.

Period 4: \$2.00 allocated to wages and/or fringes.

Period 5: \$2.13 allocated to wages and/or fringes.

Shift 2:

Effective September 1, 2022, there is an increase as follows:

Period 1: \$1.16 allocated to wages and/or fringes.

Period 2: \$1.31 allocated to wages and/or fringes.

Period 3: \$2.00 allocated to wages and/or fringes.

Period 4: \$2.15 allocated to wages and/or fringes.

Period 5: \$2.31 allocated to wages and/or fringes.

With the exception of the above correction, all of the wage rates and other conditions found in the above referenced prevailing wage determinations remain unchanged.
