LOCALITIES: All localities within Imperial, Los Angeles, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara, and Ventura Counties

DETERMINATION: IMP-2019-2, LOS-2019-2, ORA-2019-2, RIV-2019-2, SBR-2019-2, SDI-2019-2, SLO-2019-2, STB-2019-2, and VEN-2019-2

The Daily, Saturday, and Sunday and Holiday Overtime Hourly Rates published for the Craft(s)/Classification(s) below are incorrect.

Plumber, Industrial and General Pipefitter

The correct Daily and Saturday Overtime Hourly Rate should be **\$101.08**, instead of \$101.13.
The correct Sunday and Holiday Overtime Hourly Rate should be **\$124.22**, instead of \$124.32.

Plumber, Industrial and General Pipefitter (2nd Shift)

The correct Daily and Saturday Overtime Hourly Rate should be **\$111.91**, instead of \$111.96.
The correct Sunday and Holiday Overtime Hourly Rate should be **\$138.66**, instead of \$138.76.

Sewer & Storm Drain Pipelayer

The correct Daily and Saturday Overtime Hourly Rate should be **\$78.51**, instead of \$78.56.
The correct Sunday and Holiday Overtime Hourly Rate should be **\$96.22**, instead of \$96.32.

Sewer & Storm Drain Pipelayer (2nd Shift)

The correct Daily and Saturday Overtime Hourly Rate should be **\$86.90**, instead of \$86.95.

The correct Daily and Saturday Overtime Hourly Rate should be **\$108.26**, instead of \$108.31.
The correct Sunday and Holiday Overtime Hourly Rate should be **\$134.12**, instead of \$134.22.

Plumber, Industrial and General Pipefitter

The correct Daily and Saturday Overtime Hourly Rate should be **\$99.38**, instead of \$99.43.

The correct Sunday and Holiday Overtime Hourly Rate should be **\$121.96**, instead of \$122.06.

Plumber, Industrial and General Pipefitter (2nd Shift)

The correct Daily and Saturday Overtime Hourly Rate should be **\$109.96**, instead of \$110.01.

The correct Sunday and Holiday Overtime Hourly Rate should be **\$136.06**, instead of \$136.16.

Refrigeration Fitter Service/Repair

The correct Daily and Saturday Overtime Hourly Rate should be **\$99.38**, instead of \$99.43.

The correct Sunday and Holiday Overtime Hourly Rate should be **\$121.96**, instead of \$122.06

Refrigeration Fitter Service/Repair (2nd Shift)

The correct Daily and Saturday Overtime Hourly Rate should be **\$109.96**, instead of \$110.01.

The correct Sunday and Holiday Overtime Hourly Rate should be **\$136.06**, instead of \$136.16.

With the exception of the above correction, all of the wage rates and other conditions found in the above referenced prevailing wage determinations remain unchanged.
