

The predetermined increase of \$0.52 scheduled to take effect on September 1, 2020 has been reduced. The correct predetermined increase is as follows:

Effective September 1, 2020, there will be an increase of \$0.51 allocated as follows: \$0.42 to the Basic Hourly Rate, \$0.03 to Pension and \$0.06 to Other.

With the exception of the above correction, all of the wage rates and other conditions found in the above referenced prevailing wage determinations remain unchanged.
