THE DIRECTOR'S GENERAL PREVAILING WAGE DETERMINATIONS**

The footnotes in the above-referenced determinations under the Daily and Saturday overtime columns applicable to the Chief of Party, Instrumentman, and Chainman/Rodman classifications are incorrect and should read as follows:

Rate applies to daily overtime hours up to and including 12 hours worked in a workday or other overtime hours beyond 40 hours in a workweek. All other overtime is paid at the Sunday/Holiday rate. In the event that there are less than 40 hours worked Monday through Friday, then the balance of hours worked up to and including 40 hours for the workweek, or up to 8 hours for the workday, may be worked on Saturday at the straight-time rate.

With the exception of this correction, all of the wage rates and other conditions found in the above-referenced determinations remain unchanged.

The footnotes in the above-referenced determinations for the shift rates under the Daily and Saturday overtime columns applicable to the Chief of Party (Night Shift), Instrumentman (Night Shift), and Chainman/Rodman (Night Shift) classifications is incorrect and should read as follows:

Shift:

Rate applies to daily overtime hours up to and including 12 hours worked, Sunday night through Thursday night, or other overtime hours beyond 35 hours in a workweek. All other overtime is paid at the Sunday/Holiday shift differential rate. In the event that there are less than 35 hours worked Sunday through Thursday, then the balance of hours worked up to and including 35 hours for the workweek, or up to 7 hours for the workday, may be worked on Saturday at the straight-time shift differential rate.

The footnote in the above-referenced determinations for the shift rates under the Sunday and Holiday overtime column applicable to the Chief of Party (Night Shift), Instrumentman (Night Shift), and Chainman/Rodman (Night Shift) classifications is incorrect and does not apply. The Sunday and Holiday rate listed on the general prevailing wage determinations is correct.

With the exception of these corrections, all of the wage rates and other conditions found in the above-referenced determinations remain unchanged.
