DETERMINATION: 2018-1, 2018-2, 2019-1, 2019-2, 2020-1, 2020-2, 2021-1, 2021-2, 2022-1, 2022-2, 2023-1

The predetermined increase of \$2.35 scheduled to take effect on September 1, 2023 has been reduced. The correct predetermined increase is as follows:

Shift 1:

Effective September 1, 2023, there is an increase as follows:

Period 1: \$1.20 allocated to wages and/or fringes.

Period 2: \$1.30 allocated to wages and/or fringes.

Period 3: \$1.59 allocated to wages and/or fringes.

Period 4: \$1.78 allocated to wages and/or fringes.

Period 5: \$1.97 allocated to wages and/or fringes.

Shift 2:

Effective September 1, 2023, there is an increase as follows:

Period 1: \$1.33 to be allocated to wages and/or fringes.

DETERMINATION: 2018-1, 2018-2, 2019-1, 2019-2, 2020-1, 2020-2, 2021-1, 2021-2, 2022-1, 2022-2, 2023-1

The predetermined increase of \$2.35 scheduled to take effect on September 1, 2023 has been reduced. The correct predetermined increase is as follows:

Shift 1:

Effective September 1, 2023, there is an increase as follows:

Period 1: \$1.30 allocated to wages and/or fringes.
Period 2: \$1.49 allocated to wages and/or fringes.
Period 3: \$1.78 allocated to wages and/or fringes.
Period 4: \$1.97 allocated to wages and/or fringes.
Period 5: \$2.16 allocated to wages and/or fringes.

Shift 2:

Effective September 1, 2023, there is an increase as follows:

Period 1: \$1.44 allocated to wages and/or fringes.
Period 2: \$1.66 allocated to wages and/or fringes.
Period 3: \$1.98 allocated to wages and/or fringes.
Period 4: \$2.20 allocated to wages and/or fringes.
Period 5: \$2.41 allocated to wages and/or fringes.

With the exception of the above correction, all of the wage rates and other conditions found in the above referenced prevailing wage determinations remain unchanged.
