CLASSIFICATION: Apprentice Plumber, Pipefitter, Steamfitter (All Shifts)

LOCALITIES: All localities within Imperial, Los Angeles, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara, and Ventura Counties

DETERMINATION: 2018-1, 2018-2, 2019-1, 2019-2, 2020-1, 2020-2, 2021-1

The predetermined increase of \$2.26 scheduled to take effect on September 1, 2021 has been reduced. The correct predetermined increase is as follows:

Shift 1:

Effective September 1, 2021, there is an increase as follows:

Period 1: \$0.91 allocated to wages and/or fringes.

Period 2: \$1.13 allocated to wages and/or fringes.

Period 3: \$1.64 allocated to wages and/or fringes.

Period 4: \$1.80 allocated to wages and/or fringes.

Period 5: \$2.04 allocated to wages and/or fringes.

Shift 2:

Effective September 1, 2021, there is an increase as follows:

Period 1: \$1.01 to be allocated to wages and/or fringes.

Period 2: \$1.25 to be allocated to wages and/or fringes.

- Period 2: \$1.39 allocated to wages and/or fringes.
- Period 3: \$1.94 allocated to wages and/or fringes.
- Period 4: \$2.15 allocated to wages and/or fringes.
- Period 5: \$2.35 allocated to wages and/or fringes.

Shift 2:

Effective September 1, 2021, there is an increase as follows:

- Period 1: \$1.27 allocated to wages and/or fringes.
- Period 2: \$1.54 allocated to wages and/or fringes.

LOCALITIES: All localities within Imperial, Inyo, Kern, Los Angeles, Mono, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara and Ventura Counties

DETERMINATION: 2018-1, 2018-2, 2019-1, 2019-2, 2020-1, 2020-2, 2021-1

The predetermined increase of \$2.26 scheduled to take effect on September 1, 2021 has been reduced. The correct predetermined increase is as follows:

Shift 1:

Effective September 1, 2021, there is an increase as follows:

Period 1: \$1.13 allocated to wages and/or fringes.

Period 2: \$1.29 allocated to wages and/or fringes.

Period 3: \$1.80 allocated to wages and/or fringes.

Period 4: \$1.95 allocated to wages and/or fringes.

Period 5: \$2.11 allocated to wages and/or fringes.

Shift 2:

Effective September 1, 2021, there is an increase as follows:

Period 1: \$1.24 allocated to wages and/or fringes.

Period 2: \$1.43 allocated to wages and/or fringes.

Period 3: \$1.97 allocated to wages and/or fringes.

Period 4: \$2.14 allocated to wages and/or fringes.

Period 5: \$2.32 allocated to wages and/or fringes.

With the exception of the above correction, all of the wage rates and other conditions found in the above referenced prevailing wage determinations remain unchanged.
