This predetermined increase(s) for the above named craft(s) applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after September 1, 2020, until the determination(s) is/are superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project, has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

OPERATING ENGINEER: All Classifications (Areas 1 and 2), and All Shifts

The above Determinations are currently in effect and expire on June 27, 2021**.

Effective June 28, 2021, there will be an increase of \$2.80 allocated as follows: \$1.98 to Basic Hourly Rate, \$0.57 to Vacation & Holiday and \$0.25 to Other.

Effective June 27, 2022, there will be an increase of \$2.80 allocated as follows: \$2.00 to the Basic Hourly Rate, \$0.53 to Vacation & Holiday, \$0.05 to Training and \$0.22 to Other.

There will be no further increases applicable to this determination.
