IMPORTANT NOTICE TO AWARDING BODIES AND INTERESTED PARTIES REGARDING A CORRECTION TO THE DIRECTOR'S GENERAL PREVAILING WAGE DETERMINATIONS ISSUED ON FEBRUARY 22, 2021 (2021-1) AND AUGUST 22, 2021 (2021-2) FOR SUBTRADES AND SUBTRADES SHIFT DIFFERENTIAL FOR SEVERAL NORTHERN CALIFORNIA COUNTIES

Due to a change in the computer program that is used to compile the General Prevailing Wage Determinations, the 2021-1 and 2021-2 issuance of the county determinations for the subtrades and subtrades shift differential may show a half-cent (\$0.005) difference to the overtime hourly rates for some crafts/classifications in these determinations. The list of affected wage determinations is as follows.

CRAFT: Painter

CLASSIFICATIONS: Spray Painter, Paperhanger; Sandblaster, Special Coating-Brush; Structural Steel & Steeplejack 40', Special Coating Application Spray; Special Coating (Spray Steel)

LOCALITIES: All localities within El Dorado, Lassen, Nevada, Placer, Plumas, and Sierra Counties.

DETERMINATION: ELD-2021-2, LAS-2021-2, NEV-2021-2, PLA-2021-2, PLU-2021-2, and SIE-2021-2

The Daily and Saturday Overtime Hourly Rates should be \$65.22 instead of \$65.225.

CRAFT: Sheet Metal Worker

CLASSIFICATION: Mechanical Job Where Cost of Project is \$500,000 or Under **LOCALITIES**: All localities within Butte, Glenn, Lassen, Modoc, Shasta, and Sierra Counties.

DETERMINATION: BUT-2021-2, GLE-2021-2, LAS-2021-2, MOD-2021-2, SHA-2021-2, and SIE-2021-2

The Daily and Saturday Overtime Hourly Rates should be \$92.65 instead of \$92.645.

CRAFT/CLASSIFICATION: Tile Finisher

LOCALITIES: All localities within Butte, Colusa, El Dorado, Glenn, Lassen, Modoc, Nevada, Placer, Plumas, Sacramento, Sutter, Tehama, Yolo, and Yuba Counties. DETERMINATION: BUT-2021-2, COL-2021-2, ELD-2021-2, GLE-2021-2, LAS-2021-2, MOD-2021-2, NEV-2021-2, PLA-2021-2, PLU-2021-2, SAC-2021-2, SUT-2021-2, TEH-2021-2, YOL-2021-2, and YUB-2021-2 The Saturday and Sunday Overtime Hourly Rates should be \$53.13 instead of \$53.125.

CRAFT/CLASSIFICATION: Plumber: Plumber, Pipe Fitter & Refrigeration Fitter (HVAC) – 2nd & 3rd Shift **LOCALITIES**: All localities within Contra Costa County. **DETERMINATION:** CON-2021-2

The Daily and Saturday Overtime Hourly Rates should be \$150.04 instead of \$150.045.

CRAFT/CLASSIFICATION: Plumber: Plumber, Pipefitter and Pipefiter Helper **LOCALITIES**: Portions of Alpine, El Dorado, Nevada, and Placer Counties lying in the Tahoe Basin Area **DETERMINATION:** ALP-2021-1, ELD-2021-1, NEV-2021-1, and PLA-2021-1.

Plumber, Pipefitter The Daily and Saturday Overtime Hourly Rates should be \$84.35 instead of \$84.345.

Pipefitter Helper The Daily and Saturday Overtime Hourly Rates should be \$33.99 instead of \$33.995.

With the exception of the above corrections, all of the wage rates and other conditions found in the above-referenced prevailing wage determinations remain unchanged.
