REGARDING A CORRECTION TO
THE DIRECTOR'S APPRENTICE PREVAILING WAGE DETERMINATIONS**

Dear Public Official/Other Interested Parties:

CRAFT: Apprentice Electrician

CLASSIFICATION: Inside Wireman (Shift 2, Shift 3)

LOCALITIES: Alpine, Amador, Butte, Colusa, El Dorado, Glenn, Lassen, Nevada, Placer, Plumas, Sacramento, Shasta, Sierra (Portion Lying Outside The Tahoe Basin), Sutter, Tehama, Trinity, Yolo, Yuba

DETERMINATION: 2022-2

The apprentice determination published in the 2022-2 Apprentice Prevailing Wage Determinations for the above mentioned apprentice craft/classification and counties was published incorrectly for the Second and Third Shift Rates for the Pension, Other and Total Hourly Rate. The correct amounts are listed below.

Shift: 2

Period 1: Pension is \$0.56; Other is \$8.27; Total Hourly Rate is \$34.84
Period 2: Pension is \$0.63; Other is \$8.31; Total Hourly Rate is \$37.59
Period 3: Pension is \$0.71; Other is \$8.35; Total Hourly Rate is \$40.36
Period 4: Pension is \$7.10; Other is \$8.48; Total Hourly Rate is \$61.62
Period 5: Pension is \$8.29; Other is \$8.56; Total Hourly Rate is \$68.22
Period 6: Pension is \$9.47; Other is \$8.65; Total Hourly Rate is \$74.83

Shift: 3

Period 1: Pension is \$0.62; Other is \$8.30; Total Hourly Rate is \$37.15
Period 2: Pension is \$0.71; Other is \$8.35; Total Hourly Rate is \$40.25
Period 3: Pension is \$0.80; Other is \$8.40; Total Hourly Rate is \$43.36
Period 4: Pension is \$7.22; Other is \$8.54; Total Hourly Rate is \$65.61
Period 5: Pension is \$8.42; Other is \$8.63; Total Hourly Rate is \$72.86
Period 6: Pension is \$9.62; Other is \$8.73; Total Hourly Rate is \$80.14

With the exception of these modifications, all of the wage rates and other conditions found in the above-referenced determination remain unchanged.
