This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after September 1, 2022, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

Effective June 1, 2023, there is a \$1.97 increase allocated as follows: \$1.76 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.05 to Pension, \$0.03 to Vacation, and \$0.03 to Training.

Effective June 1, 2024, there is a \$1.96 increase allocated as follows: \$1.75 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.05 to Pension, \$0.04 to Vacation, and \$0.02 to Training.

Effective June 1, 2023, there is a \$1.42 increase allocated as follows: \$1.24 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.04 to Pension, \$0.02 to Vacation, and \$0.02 to Training.

Effective June 1, 2024, there is a \$1.41 increase allocated as follows: \$1.22 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.04 to Pension, \$0.03 to Vacation, and \$0.02 to Training.

Effective June 1, 2025, there is a \$1.06 increase allocated as follows: \$0.90 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.03 to Pension, \$0.02 to Vacation, and \$0.01 to Training.

Effective June 1, 2023, there is a \$1.60 increase allocated as follows: \$1.41 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.04 to Pension, \$0.03 to Vacation, and \$0.02 to Training.

Effective June 1, 2024, there is a \$1.58 increase allocated as follows: \$1.39 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.05 to Pension, \$0.02 to Vacation, and \$0.02 to Training.

Effective June 1, 2023, there is a \$1.79 increase allocated as follows: \$1.59 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.05 to Pension, \$0.03 to Vacation, and \$0.02 to Training.

Effective June 1, 2024, there is a \$1.77 increase allocated as follows: \$1.57 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.04 to Pension, \$0.03 to Vacation, and \$0.03 to Training.

Effective June 1, 2025, there is a \$1.33 increase allocated as follows: \$1.16 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.04 to Pension, \$0.02 to Vacation, and \$0.01 to Training.

Effective June 1, 2023, there is a \$1.23 increase allocated as follows: \$1.06 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.03 to Pension, \$0.02 to Vacation, and \$0.02 to Training.

Effective June 1, 2024, there is a \$1.22 increase allocated as follows: \$1.05 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.03 to Pension, \$0.02 to Vacation, \$0.01 to Training, and \$0.01 to Other.

Effective June 1, 2025, there is a \$0.93 increase allocated as follows: \$0.77 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.02 to Pension, \$0.02 to Vacation, and \$0.02 to Training.

Effective June 1, 2024, there is a \$1.31 increase allocated as follows: \$1.13 to the Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.03 to Pension, \$0.03 to Vacation, and \$0.02 to Training.
