**IMPORTANT NOTICE TO AWARDING BODIES AND ALL INTERESTED PARTIES  
REGARDING MODIFICATIONS TO  
THE DIRECTOR'S GENERAL PREVAILING WAGE DETERMINATIONS**

Dear Public Official/Other Interested Parties:

**CRAFT:** Elevator Constructor

**CLASSIFICATION:** Helper

**LOCALITY:** All localities within Imperial, Los Angeles, Orange, Riverside, San Diego, Santa Barbara and Ventura counties. Portions of Kern, San Bernardino and San Luis Obispo counties south of the Tehachapi Line.

**DETERMINATIONS:** SC-62-X-999-2023-1

**Helper**

The predetermined increase scheduled to take effect on January 1, 2024 for the abovementioned determination has been reduced from \$3.00 to \$2.89. In addition, the increases scheduled to take place on January 1, 2025, January 1, 2026, and January 1, 2027, have been reduced.

The correct predetermined increases are as follows:

Effective January 1, 2024, there is an increase of \$2.89 allocated as follows: \$1.87 to Basic Hourly Rate, \$0.10 to Health & Welfare and \$0.40 to Pension, \$0.17 to Vacation & Holiday, \$0.05 to Training and \$0.30 to Other.

Effective January 1, 2025, there will be an increase of \$2.70 allocated to be allocated to wages and/or employer payments.

Effective January 1, 2026, there will be an increase of \$2.79 allocated to be allocated to wages and/or employer payments.

Effective January 1, 2027, there will be an increase of \$2.93 allocated to be allocated to wages and/or employer payments.

**Helper (Employed in industry more than 5 years)**

The predetermined increase scheduled to take effect on January 1, 2024 for the abovementioned determination has been reduced from \$3.00 to \$2.93. In addition, the

increases scheduled to take place on January 1, 2025, January 1, 2026, and January 1, 2027, have been reduced.

The correct predetermined increases are as follows:

Effective January 1, 2024, there is an increase of \$2.93 allocated as follows: \$1.87 to Basic Hourly Rate, \$0.10 to Health & Welfare, \$0.40 to Pension, \$0.21 to Vacation, \$0.05 to Training and \$0.30 to Other.

Effective January 1, 2025, there will be an increase of \$2.70 allocated to be allocated to wages and/or employer payments.

Effective January 1, 2026, there will be an increase of \$2.79 allocated to be allocated to wages and/or employer payments.

Effective January 1, 2027, there will be an increase of \$2.93 allocated to be allocated to wages and/or employer payments.

With the exception of these modifications, all of the wage rates and other conditions found in the above-referenced determinations remain unchanged.
