Effective July 1, 2024, there will be a \$4.86 increase to be allocated as follows: \$3.62 to Basic Hourly Rate, \$0.38 to Health & Welfare, \$0.43 to Pension, \$0.31 to Vacation/Holiday, \$0.07 to Training, \$0.05 to Other.

Effective July 1, 2025, there will be a \$5.11 increase to be allocated to wages and/or employer payments.

Effective July 1, 2026, there will be a \$2.685 increase to be allocated to wages and/or employer payments.

STOCKER, SCRAPPER (All Areas and All Shifts):

Effective July 1, 2023, there will be a \$2.315 increase to be allocated to wages and/or employer payments.

Effective July 1, 2024, there will be a \$2.43 increase allocated to wages and/or employer payments.

Effective July 1, 2025, there will be a \$2.555 increase to be allocated to wages and/or employer payments.

Effective July 1, 2026, there will be a \$2.685 increase to be allocated to wages and/or employer payments.

There will be no further increases applicable to this determination.
