The predetermined increase scheduled to take effect on January 1, 2024 for the above mentioned craft/classification was inadvertently omitted. The correct predetermined increase schedules and allocation are listed below:

Effective on January 1, 2024, there will be a reallocation as follows: a decrease of \$0.35 from Pension and an increase of \$0.35 to Health and Welfare.

Effective July 1, 2024, there will be an increase of \$4.70 to be allocated to wages and or fringes.

Effective July 1, 2025, there will be an increase of \$5.00 to be allocated to wages and or fringes.

There will be no further increases applicable to this determination.

With the exception of the above correction, all of the wage rates, and other conditions found in the above referenced determinations remain unchanged.
